

TERMS AND CONDITIONS OF AQUISITION

AQUIRING AN ORIGINAL ARTWORK

An original artwork has the artist's handwritten signature on the back and is accompanied by a certificate of authenticity which states that the artwork is original and unique and is attributed to the buyer.

The client is obliged to pay in full for the artwork within a maximum of seven working days from the issuance of the invoice so that the order will be fully processed and ship out.

The client has a period of seven working days to decide if they wish return the artwork, starting from when the artwork has reached its final destination and all costs associated with the return will be supported by the client. As soon as the artwork has been returned and checked for damage, a refund will be issued within a maximum of three working days.

The integral price of the artwork does not include transportation or shipping fees or any other additional fees that may be involved in moving an artwork to various countries, locations or overseas. The client can ask the seller for a shipping quotation or deal with the transportation of the artwork themselves. In this case, it becomes the buyer's responsibility to ensure the artwork's safety and protection from all other possible side effects during shipping and transportation.

Artworks under two meters in their lengths (refers to any side/length of the work) can be shipped either on their wooden chassis, packaged and protected from elements or the canvas can be rolled and transported in a protective tube that will also be packaged and protected from elements.

Artworks that exceed two meters in their lengths (refers to any side/length of the work) will be rolled and placed in a protective tube to ensure a safer transportation.

The integral price of the artwork does not include a frame. The client can request recommendations for a suitable frame to the artwork.

AQUIRING AN ORIGINAL OR LIMITED SERIES PRINT

An original print or limited series print has the artist's handwritten signature on the back and is accompanied by a certificate of authenticity which states that the print is original and unique and is attributed to the buyer.

The client is obliged to pay in full for the print within a maximum of seven working days from the issuance of the invoice so that the order will be fully processed and ship out.

The client will not be able to return a print after its purchase and refunds will not be issued in these situations.

The integral price of the print does not include transportation or shipping fees or any other additional fees that may be involved in moving a piece to various countries, locations or overseas. The client can ask the seller for a shipping quotation or deal with the transportation of the print themselves. In this case, it becomes the buyer's responsibility to ensure the artwork's safety and protection from all other possible side effects during shipping and transportation.

Prints will be rolled and place in a protective tube and be shipped or transported as such.

The integral price of the print does not include a frame. The client can request recommendations for a suitable frame to the artwork.

COMISSION AGREEMENT

To guarantee a fair collaboration and assurance that both the collector and the artist are equally committed to the completion of a custom work, both parties will sign an agreed contract.

The commission agreement will consist of detailed information regarding purpose, costs, payment terms, copyrights, modifications or alterations and warranties.
